**Rules:** All rules of USATT will govern the tournament. All matches will be 3 of 5, except for the Open final, which will be 4 of 7. U-2200, U-2350 & Open will have top 2 players advance to the second round.

**Fees:** \$20 per event(\$30 for Open event). There is no registration or administration fee.

**Deadline:** Form and Fee must be post marked or received by **Mar 12, 2012**. Late entries will be accepted at the Tournament Committee's discretion, with a late fee of **\$10.00**.
